

NAYARA ENERGY INAUGURATES IT'S SEVENTH GANTRY IN DEVBHOOMI DWARKA

*New gantry will cater to growing retail demand of Motor Spirit (MS)/High-Speed Diesel (HSD)
Will strengthen Health, Safety, Environmental and Fire (HSEF) standards at the refinery*

Vadinar, 12 July 2021: Nayara Energy, a new-age downstream energy and petrochemicals company of international scale, inaugurated its seventh gantry at the Vadinar Refinery in Gujarat. This new gantry marks the fourth White Oil Road Loading Gantry at Vadinar along with the two LPG Road Loading Gantries and one Black Oil Loading Gantry. The new gantry was inaugurated by Dr. Alois Virag, Chief Executive Officer and Prasad Panicker, Director and Head of Refinery and Madhur Taneja, Chief Marketing Officer, along with the members of the refinery.

In line with its commitment to ensure operational safety, the gantry will be equipped with a bottom loading facility for MS and HSD at all its 8 bays as well as independent ethanol blending capabilities in MS at 4 bays. This feature will contribute to the environment, owing to reduced vapor emissions during the loading process. The gantry has been designed to cater to growing retail demand of MS/HSD and augment the HSEF standards of Nayara Energy's operations. The facility will be able to provide quicker filling of the Tank Truck's thereby providing faster product deliveries to our channel partners.

Speaking at the inauguration, **Madhur Taneja, Chief Marketing Officer, Nayara Energy** said, "As the fastest growing pan-India private fuel retail network with over 6000+ fuel stations, we are committed to meeting the growing needs of the our customers on the move and enhance their experience. This new gantry will augment dispatch capacity, as well as cater to growing retail demand through continuous product supply."
